**Updated guidance from the DFE regarding clubs and activities** - the <u>Education and</u> <u>childcare settings: national restrictions from 5 November 2020</u> guidance has been updated to clarify the position regarding wraparound childcare, clubs and activities, which has not changed. It remains that settings can continue to offer out of school childcare and schools and colleges can continue to offer clubs/activities in order to enable parents to work, seek work, attend education or training, or respite care (for vulnerable children). All clubs and activities not for these purposes should be suspended during the period of national restriction.

**Reminder on the requirements for First Aid training** – some of you have contacted us to express your concern that there are training providers offering first aid training only virtually, such as via Zoom. Please remember that the practical elements of the PFA course should be delivered face to face so competency can be properly assessed.
