COVID PPE/Cleaning Costs Grant – you should already have received an email on this (and a good number of you have already responded) but please see the detail below

Essex Early Years has secured a one off grant to support Early Years Providers with the additional costs incurred as a result of COVID. The grant is to be used to help cover the costs of PPE and additional cleaning costs **per setting** who remain open and providing childcare during the summer term and/or summer holidays 2021.

An email was sent out to providers on 24th June, if you have not received an email please submit your request using the relevant link below.

To apply for the grant you may need to provide us with your bank details for the payment to be processed. For providers who have a current FEEE contract bank details will not be required. The information submitted will be used to make the one off grant payment and will be retained by ECC for auditing purposes in line with financial regulations.

Early Years and Childcare providers are required to submit their request for the grant by close of play Thursday 8th July 2021. The grant will be paid by the beginning of September 2021.

EYFS New Online Service - the Department for Education has launched a new online service to support private, voluntary and independent early years settings and childminders to effectively implement the revised EYFS that becomes statutory from September 2021. Essex County Council, Southend Borough Council and the NHS Clinical Commissioning Groups across Essex and Southend have commissioned an ambitious project for children's therapies including speech and language therapy, occupational therapy and physiotherapy.

Key outcomes of this work will be a common framework for the delivery of all children's therapy services, removing the barriers to access and the post code lottery that currently exists across Essex.

Better Communication CIC, is supporting this work and the framework that underpins the work is **The Balanced System**[®]. This work aims to create a single system wide delivery plan for children's therapies across Essex and Southend.
