This week's update will be the last one until September, when we will resume with relevant updates as and when needed. We will of course share any urgent Covid related updates that come up during the holidays. Reminder about the food vouchers for children in receipt of Early Years Pupil Premium and FEEE2 Funding -

You are able to apply for a **£15 food voucher** for 4 weeks for every **pre-school child** that attends your setting **who is in receipt of EYPP (Early Years Pupil Premium) or FEEE2 or** Children aged 0-4 (non-statutory school age) who attend your setting who you are aware may be experiencing financial hardship at this time. This is a total of £60.00 per child. Please note the change from the previous £25 per voucher to £15 per voucher this time.

Again, Essex County Council has commissioned Wonde (now called Vouchers for Schools but please note this is still relevant for early years providers) to issue these vouchers and if you registered with the Wonde system to access either the Winter Warmth or previous Food vouchers, you will already have an account set up. To access the £15 food vouchers, childcare providers with children in receipt of **EYPP and FEEE2 funding** need to submit the number of eligible children you have registered at your setting. You will then be allocated a number of vouchers and validation codes that can be downloaded and passed directly to parents. **Please go to:** visit <https://www.evouchers.com/> and click login in the top right hand corner to log in using your email address

Updates from the DfE

- **What Step 4 changes mean for education and childcare settings**

As most restrictions across all parts of society were relaxed from Monday 19 July, the DfE want to keep schools, colleges and early years settings informed on what Step 4 changes mean. To help with this, they have recorded a [webinar](#) which provides information on the key changes to COVID-19 measures such as 'bubbles', contact tracing, face coverings, self-isolation and testing, in addition to providing answers to some frequently asked questions.

- **Changes to contact tracing for schools, colleges and nurseries from Monday 19 July**

From Monday 19 July, schools, colleges and nurseries will no longer carry out routine contact tracing. From this point onwards, close contacts will be identified and contacted by NHS Test and Trace.

In response to feedback from stakeholders, the DfE have produced guidance, some frequently asked questions and answers and a template letter for settings to send to parents, pupils and students on changes

to contact tracing of close contacts. These can all be found on the document sharing platforms for [primary and early years](#), [secondary schools, further education and higher education](#) and [children's social care](#).

The DfE have updated the actions for early years and childcare providers during the COVID-19 pandemic to reflect that we moved to Step 4 on 19 July. This includes removing the section on 'contact tracing until Step 4'. The DfE have also updated sections on clinically extremely vulnerable staff and children.
