#### **Overview of the Childcare Reforms Expansion:**

#### What is the Childcare Reforms Expansion?

The Department for Education (DfE) Childcare Reforms Expansion has been designed to better help parents and carers access childcare alongside their work responsibilities. These changes are part of the government's ongoing commitment to support families and enable parents to return to or remain in the workforce, while ensuring their children receive the care they need.

#### **Expansion of Funded Early Education Entitlements**

**From April 2024,** if you are a working parent, you may be eligible for up to 15 hours of funded childcare per week, over 38 weeks, or up to 570 hours if accessed all year round, starting from the term after your child's second birthday.

**From September 2024,** the support extends further, with up to 15 hours of funded childcare per week, over 38 weeks, or up to 570 hours if accessed all year round, available for eligible working parents from the term following your child turning nine months old.

**From September 2025,** eligible working parents will be entitled to up to 30 hours of funded childcare per week, over 38 weeks, or up to 1,270 hours if accessed all year round, starting from the term after their child reaches nine months of age.

#### 15 funded hours – 2-year-olds

- From April, eligible working parents will be able to access 15 hours of funded childcare the term after their child turns two-years-old.

Eligible working parents and carers will now be able to access up to 15 hours of funded childcare from the term after their child turns two-years-old. This is part of the Department for Education's Childcare Reforms Expansion, to support more parents back into work.

#### **Expansions to the current Funded Early Education Entitlement**

Starting April 2024, the Childcare Reforms Expansions enables eligible Essex families to access additional funded childcare.

This initiative builds on the previous Funded Early Education Entitlement offer and is a significant increase in supporting working parents and carers, providing support to enable them to work whilst ensuring childcare support is in place.

#### What does this mean for you?

·from April 2024, eligible working parents will be eligible for up to 15 hours of funded childcare per week, over 38 weeks, starting from the term after your child's second birthday.

·from September 2024, the support extends further, with up to 15 hours of funded childcare per week, over 38 weeks, available from the term following your child turning nine months old.

·from September 2025, eligible working parents will be entitled to up to 30 hours of funded childcare per week, over 38 weeks, starting from the term after their child reaches nine months of age.
